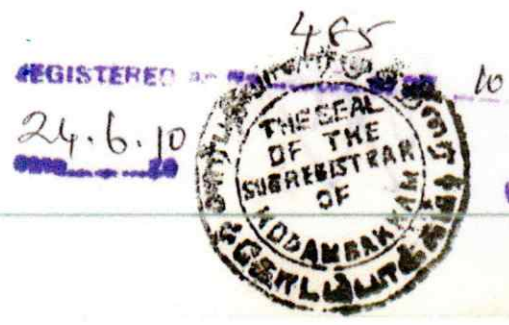

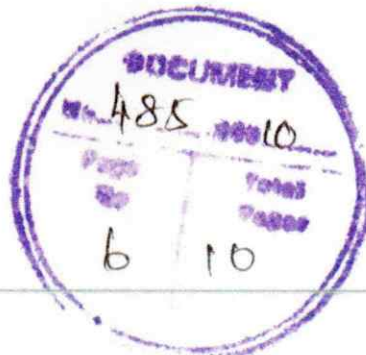

27. The trustees shall have power to appoint personnel to organize and promote the objects of the Trust and to regulate their conditions of service, including matters of discipline;

31. The activities would be confined to the territory of India;

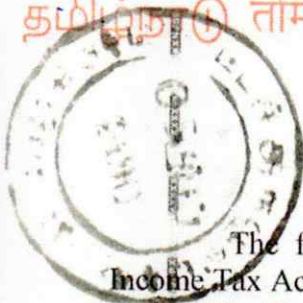

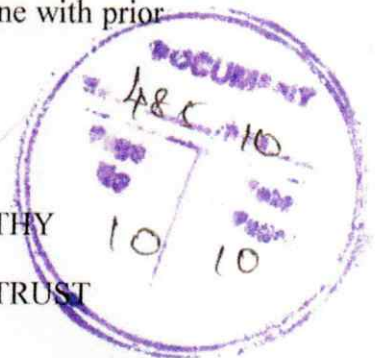


